Farm Program Update -

CSP – We got through the renewal applications assessment process, which is a lengthy and time consuming process, but we ended up with none getting funded for renewals. Our Team had none funded. It appears that only 9 or 10 total were funded in SW area. We are working hard trying to get the 2021 payment information reviewed and payments made if at all possible. Lots of scrambling going on as some need modification prior to payment etc. 2022 application period is still open for Classic CSP (That would be a new contract all together). We had been telling everyone that when a contract expires and is not refunded, they will have to wait 2 years to apply again with that land. This week the Chief waived that entire requirement for past and future signups.

EQIP – We have had some practices applied and are trying to get that reviewed and payments made. We have some 2022 applications to work on also. That cutoff for applications has passed, but people can still apply. Never know about second signups or even other types of possibilities coming up.

CCRP – We have had a few continuous CRP applications started over at FSA. At this time we have had little time to actually work on them, or look at what might be possible. It also sounds like FSA has been going through a review of CRP rental rates, and they may change a little in near future.

Administrative Items – Shantel Lozinski will be coming to Madison on occasion to help out after my planned retirement at the end of December. We will be getting her here at least a couple times before I leave to get her somewhat acclimated. Hopefully will not be too much of a mess for her to step into.

There is a job opening advertisement currently for the Madison and Ortonville locations, but there are a total of 18 positions involved in the one announcement. Looks to be open till December 20.

Upcoming Items – When my paperwork comes through December 31 will be my last day with NRCS, and since that will be the New Year's Holiday my last work day should be December 30.
